He must have been a referee, in his own nation, in Fighting System and Duo System for at least 1 year and must have refereed at least 1 Fighting System and 1 Duo System Competition. The candidate must have a good knowledge of English. Participants must send the form: Registration form for Referee Course JJEU or JJIF, which can be found on the website: <a href="http://www.jjif-referees.com">www.jjif-referees.com</a> , to the Organizer and to Mr. Roel van Ravens, JJEU Referee Committee Director. <b>The participants are strictly obligated to send a letter as well to the JJEU Referee Committee Director (e-mail address: <a href="mailto:roelvanravens@kabelfoon.nl">roelvanravens@kabelfoon.nl</a>), that their National federation gives the participant permission to follow the course. Only the examination for the Continental B license is possible.</b>
