



TO THE JJEU MEMBERS

Dear Presidents, dear delegates!

We have the privilege to invite you to the 2021 session of the JJEU General Assembly, which will take place in Slovenia on October 16th, 2021. The electoral GA should have taken place in 2020, but was postponed because of the Covid-19 pandemic.

The original announcement of the GA 2021 was to be held on the date of the German Open international tournament, which should have taken place in Germany in October. Since the DJJV cancelled the event and has already overwhelmingly stretched their unplanned activities by kindly and professionally accepting to host the JJEU Championship for Adults in July 2021 and the JJEU Championship for U18-U21, the Board has decided to organize the General Assembly in Slovenia, in the city of Brežice, at the nearby Spa Complex Terme Čatež, Topliška cesta 35, 8250 Brežice, Slovenia (<https://www.terme-catez.si/si/catez/namestitve/hotel-terme>).

The city of Brežice and its spa complex TERME ČATEŽ are located a few kilometres from the state border between Croatia and Slovenia. For plane travellers, we recommend Zagreb airport in Croatia (55 km from location) or Ljubljana in Slovenia (140 km from location). For those traveling by car, a motorway A2, exit Brežice, is the rational way (Terme Čatež are located 1 km from the A2 motorway exit). Please be aware a vignette for motorway is required!

Please check Covid-19 regulations and requirements to enter Slovenia. At the moment, EU (or approved) digital Covid-19 certificate is mandatory to enter and attend the event. LOC will assist in any questions regarding Covid-19 protocols, including official invitation to prove the business nature of your travel to Slovenia.

You may also use recommended service at <https://www.policija.si/enterslovenia/en>. The organizer will provide transport from Zagreb and Ljubljana airport to the location. Car parking is available for guests, free of charge, at the official hotel Terme Čatež ****. Normally, it is expected the delegates arrive on Friday afternoon and depart Sunday morning. Optionally, arrival to the GA directly and departure after lunch on Saturday is possible. BOOKING may be done through the local organisation only, at the e-mail address info@jjeu.eu. If you require transport from airport to the hotel and back, the prices are:

- transport from and to Zagreb airport 20€
- transport from and to Ljubljana airport 40€

Prices of the full board include two entries per person into Termal riviera, unlimited use of the hotel pool complex etc. Wi-fi is included, all rooms have AC and balcony, mini bar etc.

PLEASE NOTE: pursuing JJEU Statutes and Covid-19 restrictions, maximum two delegates per JJNO may attend, with only one with the right to vote. The vote must be expressed by the National Member President, personally, or, if the President does not attend the General Assembly, the National Member (JJNO) will appoint a delegate with voting rights, of the same nationality or holding residence in the same country (usually a Board member etc.). The appointment letter (proxy), signed by the president, must be presented in original at the General Assembly at registration. Delegate of one JJNO cannot vote in behalf of another member.

PLEASE NOTE: please make sure to take proper insurance precautions related to the Covid-19 issues. If the event is required to be cancelled because of the force majeure such as Covid-19 pandemic, the LOC (Ju-jitsu Federation of Slovenia) and JJEU cannot accept liability for not fulfilling the expected obligations.
