- 11.50 Report by the auditors presented bz Mrs. Anja Horak. Explanation of the control which was made by Mrs. Anja Horak and Mr. Linus Bruhin. The reports did not declared any irregularities and financial management was done transparent and in order so the auditors proposed to be approved.

After discussions the General Assembly DECLARED:

- 1. The JJEU accounts for years 2019 and 2020 were approved. Approved unanimously.
- 2. The JJEU business reports for 2019, 2020 and first half of the 2021 were approved. Approved unanimously.
- 3. The General Assembly discharged the JJEU Board for 2019 and 2020. Approved unanimously.
- 11.56 Vote for the Auditors: for the 2021 the GA elected Mrs. Anja Horak and Mr. Linus Bruhin. Approved unanimously.
- 11.57 Budget 2021 2022 was presented by Mr. Michael Korn. Details were published.
- 12.04 Coffee break for 15 minutes.
- 12.21 Approval of the budget. Declaration: Budget for 2021 and 2022 was approved unanimously.
- 12.28 Elections of the Board. The president explained the procedure of the elections (including option that each candidate has 5 minutes for presentation of a programme) and pass the handling of the process to the Elections Commission.

For the president, two candidates, Mr. Robert Perc, actual President, and Mr. Igor Lanzoni, FJJI Vice President. After presentation of the candidates Mr. Lanzoni withdraws as a candidate for a President (and General Secretary later) in favor of Mr. Perc.

DECLARATION: Mr. Robert Perc from Slovenia is elected as the JJEU President for period of 2021 – 2021 (unanimously with acclamation).

For the position of General Secretary, two candidates, Mr. Rick Frowyn, General Secretary, and Mr. Igor Lanzoni FJJI Vice President. In the speech of Mr. Lanzoni he announces that he withdraws for the position of President (and General Secretary).

DECLARATION: Mr. Rick Frowyn from Netherland is elected as the JJEU General Secretary for period of 2021 – 2024 (unanimously with acclamation).

For the position of First Vice President, responsible for the financial matters, two candidates: Mr. Michael Korn and Mr. Anestis Poulikidis. Mr. Didier Menu withdraw from the

DECLARATION: Mr. Michael Korn from Germany elected as the JJEU First Vice President for period 2021 – 2024 (unanimously with acclamation).

Elections for the 2nd Vice President - round 1 with ballots: 19 votes, all ballots received were valid. Elections Committee Declared:

Mr. Poulikidis: 9 votes

Mr. Menu: 10 votes

DECLARATION: Mr. Didier Menu from France was elected as the JJEU (Second) Vice President for period 2021 – 2024.

Elections for the position of 3rd Vice President - round 1 with ballots: 19 votes, all ballots received were valid. Elections Committee Declared:

Mr. Poulikidis: 13 votes

Mr. Kukoverov: 6 votes

DECLARATION: Mr. Anastasios Poulikidis from Greece was elected as the JJEU (Third) Vice President for period 2021 – 2024.

13.14 President Mr. Robert Perc announces the new board of JJEU. The General Assembly unanimously ratified the composition of the new Board for the next four years as follows:

- 13.30 Planning 2022 and further. Mr. Frowyn presented the candidacy of Greece for organizing the Europeans Youth in Heraklion, Greece. Approved. Candidates for 2023 and 2024 were in the process of evaluation and will be presented in the beginning of the year 2022.
- 13.52 Mr. Joachim Thumfart, JJIG General Director, reflected some last minutes updates related to upcoming World Championship for all categories in Abu Dhabi, UAE.
