## 4 RULES AND DRAW

The following rules apply:

- JJIF competition rules (in their latest versions) and the Organization and Sporting code of JJIF Version 3.2 (OSC).<sup>1</sup>
- We appeal to all participants to respect the fair-play and JJIF book of ethics

### 4.1 Draw modus

The seeding and draw en block will be made on **Friday February the 10<sup>th</sup> of 2023** at Klapperstraat 103, 9120 Beveren, Belgium

Immediately after the draw has been finalised, the categories will be made available online on the Sportdata Event Website..

Major changes<sup>2</sup> must be requested according to the following<sup>3</sup>:

- At official international championships, **no redraw** is possible, except for unforeseen cases when the JJIF Board may decide on a redraw.
- A redraw can be requested max. 2 hours after the draw was published but, in any case, before the start of the competition, **in writing**, to the JJIF Sports Director.

Seeding regulations of the JJIF will be observed. For the seeding, JJIF will use the world ranking list and registration to the event from **Friday February the 10<sup>th</sup> of 2023**. The JJNOs are responsible for making sure all points are correct in the raking list until this day.

### 4.2 Appeal and Challenge

## 5 RIGHT TO PARTICIPATE AND CATEGORIES

Based on the JJIF OSC 3.2, Paragraph § 3.2. Entries of Competitors:

Each JJNO may enter two (2) contestants in each category for European Cup in Duo and Show system.

### 5.1 Categories

The age following age categories<sup>4</sup> will be allowed to participate in this event

<b>Adults (+18)</b>	Older than 18 years	2005 <sup>5</sup> or older
<b>U21 (+18-21)</b>	18/19/20 years old	2003 / 2007
<b>U18 (+16-18)</b>	16/17 years old	2009 / 2006
<b>U16 (+14-16)</b>	14/15 years old	2010 / 2008
<b>U14 (+12-14)</b>	12/13 years old	2012 / 2010
<b>U12 (+10-12)</b>	10/11 years old	2013 / 2012
<b>U10 (+8-10)</b>	8/9 years old	2017 / 2016

Official JJIF Weight categories will be used<sup>6</sup>, when enough Masters inscribed we will split them up from Adults.

## 7.2 Participation Fee

**50 euro** per individual DUO/SHOW team -

*Late entry and late payment fees will be applied.*

- \* Change (of an injured) competitor until registration deadline: free
- \* Change (of an injured) competitor after registration deadline (in the same category): 10 euro
- \* Change of the category of an athlete: 10 euro. Late entry: 10 euro
- \* Additional entering of a competitor on site: 50 euro

## 8 ANTI-DOPING CONTROL

All members should make their competitors aware that there could be doping control for several athletes. The WADA code for Doping Free sports will be applied. By entering the Championship, you accept the JJIF Anti-Doping regulations<sup>7</sup>.

If you are participating in the Championship and are taking any medication or plan to take any medication, please check with your doctor whether your medicine contains any substances on WADA's 2021/2022 Prohibited List

You will need a Therapeutic Use Exemption (TUE) if it does. JJEU automatically recognises all TUEs issued by National Anti-Doping Agency (NADAs), so please contact your NADA if you need a TUE and do not already have one.

If you have any difficulty applying for a TUE through your NADO or there is no NADO in your country, please contact the JJIF.

## 9 COMPETITION DRESSING AND PERSONAL REQUIREMENTS & ADVERTISING

The JJNOs are then responsible for giving the back numbers to the athletes so that they can apply them to their gis prior to the competition. The national federations must pay the back numbers for their athletes by themselves. Participating without an official back number is not allowed.

Application: Referees can register via SportsID for the event. We expect from each participating federation that they will send for 1>5 DUO/SHOW teams 1 referee and for 6>and more at least 2 referees.

## 11 COACHES & MEDICAL PERSONNEL FROM JJNOS

### 11.1 Coaches

All official coaches should receive their accreditation cards during accreditation. Teams without an official coach will participate without coaching (no athlete or other officials will be allowed to enter the field of play unless they register as coaches).

### 11.2 Medical personnel

JJNOS may have<sup>9</sup> their medical personnel. To receive an accreditation card as medical personnel the attendance at the medical meeting<sup>10</sup> is mandatory.

### 11.3 Dress code

Coaches and medical personnel coming on the FOP must wear official team dresses<sup>11</sup>, shorts, flip-flops, hats are not allowed.

Filming (including mobile videos) inside the FOP is not allowed without press accreditation.

According to GAISF guidelines, every competitor who has won a medal has to attend the ceremony to receive their trophy in person<sup>12</sup>.

## 12 FLAGS AND ANTHEMS

The head of each delegation, or designated responsible of each national federation, must check the flag and the national anthem during the accreditation process.
