V. COMPETITION RULES

- Fighting:** **Children U14, Cadets U16, Aspirants U18, Juniors U21 and Adults:** JJIF Rules – for Children U14 and Cadets U16 previous U15 rules apply
- Children (U12):** all three parts, no punches to the head, without locks and strangulations, full Ippon possible, the Osae-Komi 10 seconds for Ippon, 6-9 seconds for waza-ari, fight duration 2 minutes
- Children (U10):** all three parts, no punches to the head, without locks and strangulations, full Ippon possible, the Osae-Komi 10 seconds for Ippon, 6-9 seconds for waza-ari, fight duration 1,5 minute
- Ne-waza:** **Cadets (U14 and U16), Aspirants, Juniors and Seniors:** JJIF Rules
- Duo-system:** **All categories:** JJIF Rules (2023)

No-Gi team competition: The competition would be held in the form of a no-gi quintet. Teams are composed of five competitors and compete against other teams. Each team sends one member to the tatami, and the one who wins stays on the tatami. The loser leaves the tatami and his team sends the next competitor. The order of competitors is determined beforehand and blindly, so teams do not know the order of other teams. The winning team is the one that first defeats all opponents. Victory can only be achieved through submission. In case of a tie, both competitors leave the tatami and the next pair comes to compete.

In the event that both teams have the last competitor on the tatami and the regular time ends in a tie, the tie is resolved by the fastest escape/submission. The competitors draw to determine who will start in which position and sit in a seated back control. When the referee signals the start of the fight, we start counting the time. The fight ends when the competitor escapes from the back control or the attacking competitor forces him to submit. Then the competitors change positions and try to beat the time of the previous round. Either escape faster or finish the opponent faster.

The round lasts 6 minutes. All techniques are allowed except slams, neck cranks, and classic "dirty techniques" such as eye poking, etc. (we are considering banning heel hooks so the competition does not turn into one big leglock diving festival with explosive and dangerous submission attempts...to be determined).

The draw is made beforehand and teams compete through brackets until the final victory. In the event of four teams or fewer, all compete against everyone.

VI. RIGHT TO PARTICIPATE

Competitors registered before the deadline: **March 15th**.

Competitors with proper weight and valid personal identification document.

VII. TROPHIES, MEDALS

Gold, silver and bronze medals in each category.

Fair Play Trophy will be awarded for sportsmen like behavior (provided by the JJEU).

VIII. REFEREES

Slovenian and guest referees with valid license. Ju-jitsu Federation of Slovenia shall appoint the Head Referee of the Tournament.

Each team is kindly requested to contribute at least one referee with a valid licence.

Organizer will provide lump-sum for referees in line with the national regulations (JJFS).

Referees will have free meals provided at the Sports Hall during the competition.
